

## Brentwood Borough Infrastructure Funding Statement 2019/20

April 2020

## Introduction

This Infrastructure Funding Statement sets out income and expenditure relating to section 106 (S106) agreements for the year 2019/20. All authorities are required to produce an infrastructure funding statement on an annual basis. This is Brentwood Borough Council's first infrastructure funding statement.

The statement provides a summary of financial contributions the Council has secured through S106 agreements from new developments for off-site infrastructure works and affordable housing,
